### **MACQUARIE GLOBAL INFRASTRUCTURE TOTAL RETURN FUND INC. ANNOUNCES REGULAR QUARTERLY DISTRIBUTION**

**NEW YORK, March 1, 2018** – The Board of Directors of Macquarie Global Infrastructure Total Return Fund Inc. (NYSE:MGU) (the “Fund”) declared on March 1, 2018, a regular distribution for the quarter ending February 28, 2018 of \$0.37 per share.

Based on the Fund’s net asset value (“NAV”) of \$26.20 and New York Stock Exchange closing market price of \$23.05 on February 23, 2018, the \$0.37 per share distribution is equal to an annualized distribution rate of 5.65% at NAV and 6.42% at market price, respectively.

A portion of the distributions may be treated as paid from sources other than net income, including, but not limited to, short-term capital gain, long-term capital gain and return of capital. The final determination of the source of all distributions in 2018, including the percentage of qualified dividend income, will be made by the Fund after December 31, 2018.

This distribution will be payable on March 29, 2018 to shareholders of record on March 16, 2018, with an ex-dividend date of March 15, 2018.
